- c. Community Certificate.

5. He/She is directed to surrender his/her original employment exchange registration card at the time of his/her joining duty so as to send the same to the Employment Exchange concerned for removal of his/her name from the Live Register of the Employment Exchange.

6. He/She is informed that no representation of any kind regarding joining time will be entertained and that if he/she fails to join duty within the specified time and at the specified place his/her name will be deleted from the approved list of candidates selected to the post of Junior Assistant by the Appointments Authority.

7. He/She is informed that his/her appointment is temporary and the Selection is made based on his/her claim made in his/her application for the said recruitment and that any of his/her claim is found to be false his/her selection and appointment will be cancelled without any further notice.
