ORDER: -

Tmt.R.Seetha has joined in service as Accountant through selection and appointment of TNPSC CSS-IIA 2013-2014. She was joined in service on the forenoon of 16.06.2015 and being a scheduled tribe candidate, her certificate genuinity was about to be verified by the authorities concerned. Hence, due proposal for verification was made reference 5th cited.

Subsequent to that, in the reference 12th cited, the Chairman, State Level Scrutiny Committee - II/ Addl. Secretary to Government has stated that the Community Certificate No.2686829 Dated.11.07.2000 issued to Tmt.R.Seetha D/o.Thiru.Raju (Late) by the Revenue Divisional Officer, Mannarkudi was verified and found that the certificate is genuinely issued.

In the reference 13th cited, the Nilgiris District Treasury Officer has been entrusted to regularize the service of the employee. Hence, under Rule 23(a) of the General Rules in Tamil Nadu State and Subordinate Services Rules, the Services of Tmt.R.Seetha, Formerly Accountant, District Treasury, The Nilgiris is regularized in the cadre of Accountant in Tamilnadu Ministerial Services with Effect from the date of her joining i.e., Forenoon of 16.06.2015.


It is also informed that this **"Regularisation is subjected to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to Group II-A Service/2013-14** and any other criminal cases relating to this recruitment.

Under Rule 27 of the General rules of Tamil Nadu Subordinate Service Rules, the above Accountant is placed under probation for a period of two years of duty, within a period of continuous three years. The period of probation will commence from the date of regularisation.

Further, it is also informed that the above accountant has to pass Account Test for Subordinate Officers Part I, Part II and Tamilnadu Office Manual Test within the period of their probation and passing of above examinations is the condition prescribed for declaration of probation as per Annexure V of Special Rules for Tamilnadu Ministerial Services.
