(1) Thiru.M.Adaikalam, S/o.(Late).Thiru.A.Marimuthu was appointed as Junior Assistant on compassionate grounds as per this court's proceedings cited in the reference (2) above due to the death of his father Thiru.A.Marimuthu who was working as Junior Assistant, District Munsif-Cum-Judicial Magistrate Court, Cheranmahadevi and died on 13.08.2019. He has joined duty as Junior Assistant on 01.03.2021 Forenoon in Additional District Munsif Court, Sankarankovil and now he is working as Junior Assistant in Principal District Court, Tirunelveli.

The post of Junior Assistant comes under the purview of Tamilnadu Public Service Commission. Proposal for regularization of service of the individual is to be sent to the Government after getting concurrence from the Tamilnadu Public Service Commission. Hence, proposal for regularisation of service of the individual in the prescribed format with enclosures as per the instruction given in the G.O. 3rd cited in the reference, was submitted to the Hon'ble High Court in the references cited (5) and (7) above.

The Hon'ble High Court, Madras in its letter under reference cited (8) above has instructed to take necessary action to regularize the services of the above said individual, as per the G.O.Ms.No.18, Labour and Employment (Q1) Department dated.23.01.2020, since his case does not require any relaxation of rules and exemption of Government orders by enclosing the copy of Government letter in No. 9878547/நீ.ம.5/2025-1, dated.04.08.2025.

Hence, the temporary services of the above said individual who was appointed temporarily on compassionate grounds as Junior Assistant (Category of 5 of Class IV of Tamil Nadu Judicial Ministerial Services) is regularised with effect from the date mentioned against him.
