


ORDER:

She had joined duty at ESI Dispensary, Egmore @ Chetpet, Chennai on 17.09.2020 F.N.

The temporary service of the individual is regularized w.e.f. 17.09.2020 F.N. i.e., from the date of joining duty of the individual subject to the following conditions:-
