ORDER:

The following candidate was selected provisionally by Tamil Nadu Public Service Commission for appointment by direct recruitment to the post of Junior Assistant in the Tamilnadu Ministerial Service included in Combined Civil Service Examination-IV for the 2015-16, 2016-17 and 2017-18 and as per the proceedings of the Joint Commissioner (ST), Tirunelveli in the reference 2nd cited, the individual is allotted to Sivakasi Commercial Taxes District for appointment as Junior Assistant. 3. The above individual shall be on probation for a total period of two years on duty within a continuous period of three years vide rule 32 (a) (i) of Tamilnadu Ministerial service rules.

As per Annexure V referred to in Rule 34 of Tamilnadu Ministerial Service the above individual has to complete the test of Tamilnadu Government Office Manual within their prescribed period of probation, otherwise, they may be dealt as per the provision under General Rule 27 of Tamilnadu State and Subordinate Service.
