The Transport Commissioner in his letter 3rd read above has stated that, Thiru.R.Prasanth, S/o. Thiru.J.Rajkumar has been appointed as Junior Assistant under compassionate ground vide proceedings of the Transport Commissioner, Chennai in R.No.26089/RB1/2018 (E.O.No.585/2020), dated 28.11.2020, since his father Thiru.J.Rajkumar, Office Assistant, while working at Unit Office, Kangeyam under the control of Regional Transport officer, Tiruppur (South) be invalided from service under rule 24(b) of Part-I to Annexure-II under Fundamental Rule-74 on Medical Grounds and order to retire the individual from service on Medical Grounds on the afternoon of 30.11.2017. Thiru.R.Prasanth has joined duty as Junior Assistant on 21.12.2020 F.N. in the Office of the Transport Commissioner, Chennai-5.

2. Pursuant to the joining of the individual in the Department, the Transport Commissioner has sent proposal to Government for regularization of the services of Thiru.R.Prasanth in the post of Junior Assistant with effect from 21.12.2020 F.N.

3. The Government have carefully examined the proposal of the Transport Commissioner with the relevant records/documents of Thiru.R.Prasanth, S/o. Thiru.J. Rajkumar appointed as Junior Assistant under compassionate ground in the light of the instructions issued in Government Order second read above and accordingly, direct that the services of Thiru.R.Prasanth be regularised in the post of Junior Assistant with effect from 21.12.2020 F.N. The individual is eligible for drawing annual increments if any, as per Rules in force.

4. This order issues with the concurrence of the Labour welfare and Skill Development Department vide its U.O. No.14906/Q1/2021, dated 06.09.2021 and Human Resources Management Department vide its U.O. No.28135/G1/2021-1, dated 14.09.2021.
