The period of probation Sl.Nos. 1 to 7 are two years on duty within a continuous period of 3 years. But, before that, their services have to be regularised, since the probation commences only from the date of their regular appointment.

As per the letter No. 535/PSD-G<sub>1</sub>/2016, dated 19.01.2016 of Tamil Nadu Public Service Commission, while regularising the services of Sl.No.2 the following para is included in the regularization orders to be served to the individuals.

" The regularisation is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to Group IV Services for the year 2013-2014 and 2014-2015 recruitment".

The period of probation Sl.No. 8 is one year on duty within a continuous period of 2 years. But, before that, his services has to be regularised, since the probation commences only from the date of his regular appointment.

\* Selvi. P.Ananthi, Steno-typist Grade-III, Mobile Court, Salem has previously submitted resignation on 25.07.2016 and the same was not accepted by the Principal District Judge, Salem in Roc.No.1664/A/2017 dated 16.02.2017 and directed to report to duty within 2 weeks and she joined duty on the forenoon of 01.03.2017 and her absence period from 26.07.2016 to 28.02.2017 was treated as extra ordinary leave without allowance, totally 218 days leave on loss of pay.

She has completed the Certificate Course on Office Automation in the **June 2013**.

The above said individuals have already been submitted their Physical Fitness Certificate at the time of joining.

No Disciplinary proceedings or any other enquiry is pending against the above said individuals. The service register and record sheet of the individual is submitted herewith for your Honour's kind perusal.
