ORDER:-

Based on the announcement made by the Hon'ble Chief Minister, Tmt.E.Vishnupriya, D/o. Thiru S.Egaraj, Fireman (who died on 16.07.2017 while attending the Fire Call at MKB Nagar, Chennai) was appointment as Junior Assistant in Fire and Rescue Services Department on compassionate ground as a special case in the Government order first read above.

- 2. The Director General of Police / Director, Fire and Rescue Services, Chennai in the letter second read above, has stated that Tmt.E.Vishnupriya, had reported for duty as Junior Assistant in Fire and Rescue Services Department on 01.10.2018 F.N. and the individual had possessed the educational and age qualifications prescribed for the post of Junior Assistant. The Director General of Police / Director, Fire and Rescue Services, Chennai has therefore requested to regularize the services of Tmt.E.Vishnupriya, Junior Assistant who was appointed on compassionate ground with effect from the date of her appointment on 01.10.2018 F.N.
- 3. The Government have examined the proposal of the Director General of Police / Director, Fire and Rescue Services, Chennai and found that Tmt.E.Vishnupriya, got married prior to her appointment as Junior Assistant on compassionate ground. Though as per the Government order third read above, married daughters of the deceased Government servants are also eligible for appointment on compassionate grounds, the

relevant Section 15 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 has not been amended to that effect. Hence, Section 15 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 has to be relaxed in favour of the individual. Further, to accord monetary benefits from the date of appointment of the individual, Section 28 (2) of the above said Act has also to be relaxed in her favour.

- 4. Therefore, in exercise of the powers conferred under Section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 the Governor of Tamil Nadu hereby relaxes the Sections 15 and 28 (2) of the above said Act, in favour of Tmt.E.Vishnupriya, Junior Assistant in Fire and Junior Assistant from the date of her initial appointment on compassionate ground i.e. from 01.10.2018 F.N. and to grant monetary benefits thereon on due dates.
- 5. Accordingly, the Government direct that the services of Tmt.E.Vishnupriya be regularized in the post of Junior Assistant from the date of her initial appointment on compassionate ground i.e. from 01.10.2018 F.N. and grant monetary benefits thereon on due dates, by relaxing Sections 15 and 28 (2) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016.
