ORDER:

He was released to Directorate of Medical Education, Chennai side for postings and he was posted to Kasturba Gandhi Hospital for Women and Children, Chennai vide reference 2nd and 3rd cited respectively. He has joined duty in the post of Assistant on the Forenoon of 31.12.2012. He is fully qualified to hold the post.

Accordingly the temporary Services of Thiru.B.Senthil Kumar, Assistant, Chengalpattu Medical College, Chengalpattu is regularized in the post of Assistant with effect from the date of joining duty in the post of Assistant i.e. from 31.12.2012 Forenoon, subject to the following condition.

“ The regularization is subject to final outcome of the WPs/Cases relating to Combined subordinate services Examination I 2009-2011 pending on the files of the Honourable High Court of Judicature at Madras / Madurai Bench of Madras High Court and any other criminal cases relating to this recruitment “

He is placed on probation for a period of two years within the continuous period of three years from the date of regularization of temporary services.

He should pass the following Departmental Test / Qualification within his Probationary period.

1. Tamil Nadu Medical Code
2. Accounts Test for Subordinate Officers Part – I
3. Tamil Nadu Government Office Manual Test
4. Foundational training for a period of two months at Civil services Training institute, Bhavanisagar
5. Adequate knowledge in Tamil, If not he should pass the Language test in Tamil
