ORDER:

Additional District Court, Tiruchirappalli died in harness on 21.03.2015. His son Thiru.P.Harish Pillai, has applied for the post of Junior Assistant in the Tamil Nadu Judicial Ministerial Service on compassionate grounds. The date of birth of Thiru.P.Harish Pillai, is 26.08.1994. He has passed S.S.L.C., and H.S.C., He is thus eligible for appointment as Junior Assistant in the Tamil Nadu Judicial Ministerial Service. He was therefore appointed temporarily as Junior Assistant in the Principal District Court, Tiruchirapalli and joined duty on the Forenoon of 06.12.2017. The Registrar (District Judiciary), High Court of Madras, has sent proposal for regularisation of the services of the above individual as Junior Assistant in the Tamil Nadu Judicial Ministerial Service with effect from 06.12.2017 F.N.

2. The Government after careful examination have decided to accept the proposal of the Registrar (District Judiciary) High Court of Madras, Chennai and verified all the original certificates of the individual

regarding the appointment in the post of Junior Assistant on Compassionate Ground. Accordingly, the Government direct that the services of Ground. Accordingly, the Government direct that the services of Thiru.P.Harish Pillai, S/o. (Late) Thiru.M.Panneer Selvam, Formerly Stenographer Grade I, II Additional District Court, Tiruchirappalli appointed on compassionate grounds be regularised in the post of Junior Assistant under the Tamil Nadu Judicial Ministerial Service in the Principal District Court, Tiruchirapalli with effect from 06.12.2017 F.N. subject to the condition that the individual should possesses the physical fitness to hold the post in which he is regularized and ordered accordingly. In view of the retrospective regularisation, the individual is eligible to draw the annual increments and arrears of pay and allowances if any, as per the rules.
