2. They shall join duty on the F.N. of 15.11.2023 with a Medical Fitness Certificate issued by a Medical Officer not below the rank of an Assistant Civil Surgeon.

- 3. The individuals are also informed that no kind of representation regarding joining time will be entertained and that if he/she fails to join duty within the specified time and at the specified place, his/her name will be deleted from the approved list of candidates selected to the post of Junior Assistant included in Combined Civil Services Examination IV (Group IV)
- 4. The individuals are also informed that the appointment is temporary and selection is made based on their claims made in their application for the said recruitment and that if any of their claim is found to be false, their selection and appointment will be cancelled without any further notice.
- 5. The appointment of candidate in Sl.No.34 Tmt./Selvi.M.Adline Rini is subject to the following condition:

"The commission has requested the Appointing Authority to verify the community claim of the aforesaid candidate by referring the individual's case to the District Vigilance Committee and her claim may be accepted on receipt of the final report from the District Vigilance Committee, along with records of enquiry. If her Community Claim is found to be not genuine, she is liable to be terminated from service and for which penal and legal action including recovery of salary as consequence thereof will be initiated. The temporary services of the individual should not be regularized in the said post until her Community claim is accepted as genuine"

"The commission has requested the Appointing Authority that the PSTM claim of the aforesaid 9 candidates may be referred to the appropriate authorities viz. The Director of School Education for verification duly obtaining the PSTM certificates from the above said candidates after joining duty. The PSTM claim may be accepted after the receipt of genuineness report from the authorities concerned. After acceptance of his / her PSTM claim, the fact may be informed to the Commission

along with a copy of the genuineness report, so as to finalise his / her provisional and conditional selection. The temporary services of the above said candidates should not be regularized in the said post until his / her / their claim is / are found to be genuine.

- 7. The individuals should submit their Employment Exchange registration card if any, to this office.
- 8. The individuals are also informed that the candidate who do not possess "Adequate knowledge in Tamil" should pass II class language test (full test) in Tamil within the period of probation (2 years from the Date of Appointment) as per the Section 21(1) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016.
