The above individual is placed on probation for a total period of two years on duty within a continuous period of three years, with effect from 03.08.2020. orders on declaration of probation of the individual will be issued by this Unit on completion of probation period by the individual and subject to the condition that he acquires the other required qualifications during the above period.
5. The above individual shall within the period of probation:-
(a) Complete the foundational Training for a period of two months at Civil Services Training Institute, Bhavanisagar.
6. He is informed that no kind of representation regarding joining time will be entertained and if he fails to join duty within the specified time and at the specified place, the commission will be addressed for removal of his name from the approved list of candidates selected to the post of Junior Assistant with reference to Rule 23 of the Tamil Nadu Public Service Commission Rules of Procedure 2017.
7. He is also informed that the appointment on provisional selection is made based on his claim made in his application for the said recruitment and that if any of his claim is found to be false, his selection and appointment will be cancelled without any further notice.
