ORDER:

Thiru.P. Karthi, who was selected by Tamil Nadu Public Service Commission as per the reference 2st and 3rd cited, and appointed temporary as Junior Assistant under rule 10 (a) (i) has joined duty in this college on 07.09.2020FN. He is fully qualified to hold the post, he has completed one year of his service.

Hence, the temporary service of **Thiru.P.Karthi, Junior Assistant** is regularized with effect from 07.09.2020FN i.e. the date of joining in the Government service subject to the following conditions.
