Further, it is informed that this is not a seniority list. This list is based on the selection list forwarded by TNPSC, at the time of their initial appointment. Hence, the right on seniority may not be claimed, based on the above list.

Further, it is also informed that, the regularisation is subject to the outcome of the Writ Petition (if any) pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to Group IIA (Non Interview Post) 2017-18 recruitment.

As per the provisions of Para 7 and 8 to Annexure IX-E of Rule

38(b) (ii) of Special Rules for Tamil Nadu Ministerial Service,

"7. Every person appointed as Assistant by direct recruitment shall be on probation for a total period of two years on duty within a continuous period of three years.

"8. Every person appointed as Assistant by direct recruitment

shall within the period of probation,-

Complete the Foundation Training for a period of two (a) months at Civil Services Training Institute, Bhavanisagar; and

Pass the following tests, namely:-(b)

(i) Tamil Nadu Government Office Manual Test

(ii) Account Test for Subordinate Officers, Part-I;

(iii) Department Test on Motor Vehicles Act and Rule.

Hence, the above individuals are also placed under probation for a total period of two years on the duty, within a continuous period of three years and instructed to pass all the above prescribed tests within the period of probation; failing so, action will be initiated against the individuals as per Sections 31 and 32 of Tamil Nadu Governments Servants (Conditions of Service) Act, 2016.

The Officers concerned are requested to make necessary entries in the Service Register of the individual and intimate the fact to this office

immediately.
