Thiru.G.Janarthanan, was selected provisionally by the Tamil Nadu Public Service Commission through direct recruitment and allotted to this department, was appointed on 07.02.2018 F.N. as Typist purely on temporary basis in the office of the Additional Director General of Police/Inspector General of Prisons, as per this office proceedings in the reference second cited and he is working as such from the above date.

2) The services of the above individual in the post of Typist, is regularized with effect from the date of his joining duty, subject to the outcome of Writ Petitions relating to Group IV Service 2015 - 2016 recruitment pending on the files of the Hon'ble High Court of Madras/ Madurai Bench of the Hon'ble High Court of Madras.

3) He is placed on probation for a period of two years on duty within a continuous period of three years. During this period, he should pass the Tamil Nadu Government Office Manual Test.

4) He is also informed that as per Annexure V – Item 5A – of the Tamil Nadu Ministerial Service Rules, he should pass the "Certificate Course in Computer on Office Automation" awarded by the Directorate of Technical Education within the period of probation (or) within two years from the date of appointment to the post, in addition to the Technical Educational Qualification for the post of Typist. Those, who possess Degree(or) Diploma in Computer Science (or) Computer Engineering as one of the subjects approved by the University Grants Commission (or) All India Council for Technical Education (or) Directorate of Technical Education (or) an equivalent body are exempted from passing the "Certificate Course in Computer on Office Automation" awarded by the Directorate of Technical Education.
