ORDER:

Under Rule 23 (a) of the General Rules for the Tamil Nadu State and Subordinate Services the temporary services of Tmt.A.Aruljothi, Steno –Typist Grade III, O/o the Designated Officer, Food Safety and Drugs Administration Department, Perambalur, is regularised with effect from 17.01.2014 F.N.

She is placed on probation for a period of two years on duty within a continuous period of three years with effect from 17.01.2014 F.N. in the post of Steno –Typist Grade III.

The probation will be declared only after getting a pass in the said Certificate Course and she shall not draw her subsequent periodical increment.

Further her regularisation is subject to the outcome of the WPs relating to Group IV 2007 – 2008 to 2012 – 2013 recruitment pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras.
