- 8. The above named individuals are informed further that:-
 - (a) Attention is invited to Act 20 (5) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 according to which the physical fitness of the candidates has to be decided by the appointing authorities themselves. Therefore, you are requested to satisfy yourself about the physical fitness of the selected candidates before appointing them on regular basis.
