ORDER

Thiru V.Yogeshwar, S/o M.Venketesan (Late), Cooperative Sub-Registrar who expired on 23.04.2020 while in service was appointed temporarily as Junior Assistant with effect from 14.02.2024 FN under Tamil Nadu Ministerial Service in Cooperative Department, on compassionate grounds at the time of death of the Government employee, the age of the individual was 24 years (Date of birth 29.03.1996). As per the reference 4th cited above, Thiru V.Yogeshwar was appointed as Junior Assistant on Compassionate Grounds, at the time of appointment the age of individual was 28 years. The family of the deceased Government servant was reported to be under indigent circumstances. He has satisfied all the conditions including the age limit and other prescribed qualifications for appointment on compassionate grounds and his education qualification was HSC. (Passed). As he possesses the age and educational qualifications prescribed in the special rules to the post of Junior Assistant, the service of Thiru

V.Yogeshwar as Junior Assistant from the date of his temporary appointment 14.02.2024 F.N. in Cooperative Department has to be regularized.

Hence as per Rule 16 of the Tamil Nadu Civil Services (Appointment on Compassionate Grounds) Rules, 2023, it is ordered that the services of Thiru V.Yogeshwar is being regularized at the cadre of Junior Assistant of Cooperative Department under the Tamil Nadu Ministerial Services with effect from 14.02.2024 F.N. as he is found to be physically fit for appointment to the said post.
