REGULARIZATION OF SERVICE AS TYPIST – ORDERED

In accordance with the Chief Office orders in C.No.227212/NGB 2(2)/2016, dated 11.01.2018 and 07.02.2018 and orders of the Joint Commissioner of Police, South Zone, Chennai in Rc.No.Estt.M/SZ/5649/2018, SZO. No.139/2018, dated 21.02.2018, Tr. K. Ashok Kumar, Data Entry Operator, Greater Chennai Police was appointed as Typist by transfer of service and posted to TSP III Battalion, Veerapuram, Chennai. He was reported duty in this office on 05.04.2018 FN as per this office orders in Rc.No.A1/7159/2015, B.O.no.191/2018, dated 16.04.2018.

2) In the Chief Office Circular memorandum in C.No.041769/CAR.1/2016, dated 21.12.2017, instructions were issued for regularization of services of those who were appointed as Junior Assistants/Typists from the post of Data Entry Operators as follows:

"For regularizing the service of those who were appointed from one sub-ordinate service to another sub-ordinate service, the concurrence of the TNPSC is not necessary. The post of Data Entry Operator is listed under the Tamil Nadu General Sub – Ordinate Services, whereas the posts of Junior Assistant/Typist were listed under the Tamil Nadu Ministerial Services. However, considering the pay scale of the posts of JA/Typist, it is construed that these posts come under the sub-ordinate services. Hence, the concurrence of the TNPSC is not necessary for regularizing the services of those who were appointed as Junior Assistant/Typist from the post of Data Entry Operator".

The above rule is applicable for those who were initially appointed as Data Entry Operator on compassionate grounds and later on appointed as Junior Assistant/Typist from the post of Data Entry Operator. Their services may be regularized by the appointing authority itself and the fact may be intimated to Chief Office, Chennai.

3) In pursuance of the above said Chief Office instruction, the services of above Tr. K. Ashok Kumar, Typist who was appointed as Typist from the post of Data Entry Operator is regularized with effect from his date of appointment as Typist i.e., 05.04.2018 FN.


