ORDER:

Under Section 7(1) of Tamil Nadu Government Servants (Conditions of Service) Act-2016, Tmt / Selvi.P.SONIYA GANDHI a candidate allotted by Tamil Nadu Public Service Commission to the Department of Employment and Training (Training Wing) is appointed temporarily as JUNIOR ASSISTANT in the Pay Matrix Level 8 with scale of pay 19500 – 71900 of Tamil Nadu Revised Pay Rules 2017 with usual allowances admissible as per rules and posted in the Office of Principal, Government Industrial Training Institute, Ulundurpet subject to the following conditions:

1. It is directed to report for duty before the Principal of the Government Industrial Training Institute, Ulundurpet of the concerned authority within 7 days from the date of receipt of this order. No kind or representation regarding joining time shall be entertained. If you fail to join duty within the specified time and at the specified place, your name will be deleted from the approved list of candidates selected to the post of Junior Assistant in Combined Civil Services – IV (Group IV).
2. The candidate should produce a valid Photo Identity card as a proof to the authority concerned at the time of joining.
3. At the time of joining duty, the candidate should submit a Physical Fitness to the authority concerned by producing a Certificate in the prescribed format issued by a Medical Officer not below the rank of Assistant Civil Surgeon. The differently

abled candidates should produce the Certificate of Physical fitness issued by Medical Board in the prescribed format indicating the nature of disability, percentage of disability and her capacity to perform duties. The appointment is liable to be cancelled if the candidate is found to be physically unfit for the post to which she is temporarily appointed.

4. The appointment is purely temporary and the provisional selection is made on the basis of your claims made in the application for the said recruitment. If any of the claims is found to be false, your provisional selection and appointment will be cancelled without any further notice.
5. The provisionally selected candidate should produce original and acceptable documents regarding education / technical qualifications, age, community etc., in original as well as a photocopy for verification to the Authority concerned at the time of joining duty. Failure to produce the required certificates at the time of joining will lead to cancellation of the provisional appointment.
6. It is further informed that as per Section 7(5) of Tamil Nadu Government Servants (Conditions of Service) Act 2016, if an approved candidate selected by the Commission for appointment, fails to join duty, she shall forfeit her right for appointment to the post and her name shall be removed from the approved list.
7. If you had registered in Employment Exchange, at the time of joining duty, you should surrender the Employment Exchange Registration Card in original to the authority concerned. If not registered, an undertaking to that effect must be furnished.
8. You will be under probation for a period of two years from the date of regularisation of temporary services in the post of Junior Assistant. You should undergo the Foundational training course conducted by Civil Servants Training Institute, Bhavanisagar and pass the tests prescribed within the probation period.
9. As per Rule 21 of Tamil Nadu Govt Servants (Conditions of Service) Act 2016, any candidate who does not possess adequate knowledge of Tamil at the time of application should pass the Second Class Language Test in Tamil conducted by TNPSC within the probation period, failing which She will be discharged from service.
10. The selection of candidates made under PSTM (Persons Studied in Tamil Medium) is purely conditional subject to verification and acceptance of the PSTM certificate from the competent authority. The PSTM claim shall be accepted only after the receipt of genuineness report from the authority concerned. Until then, the temporary services of such candidates shall not be regularised.

11. The candidate is not eligible for any travelling allowance or whatsoever toward s the journey performed to join duty.
