ORDER:

A list of candidates selected provisionally for appointment by direct recruitment to the post of Junior Assistant included in Group-IV Service for the year 2015-2016, 2016-2017 and 2017-2018 received in the reference 1st and 3rd cited were appointed and posted as Junior Assistant to various offices as per the reference 2nd and 4th cited. Out of the 51 candidates, the Services of the 46 junior assistants have already been regularized vide reference 5th cited.

While forwarding selection list in the reference 1st & 3rd cited, among others TNPSC have stated that, in respect of Thiru.V.Ramamoorthi (Regn.No.120137009 Sl.No:1 in shortfall) the State Level Scrutiny Committee may be addressed by the Head of the Department itself and the community claim of the individual may be accepted based on the final report of State Level Scrutiny Committee. The Tamil Nadu Public Service Commission also stated that, his temporary services should not be regularised in the said post, until the genuineness of their community claim is accepted by the Department.

Now in the reference 7th cited, the State Level Scrutiny Committee has issued a proceedings in favour of Thiru.V.Ramamoorthi, S/o.Venkattaraman for his community claim as "Hindu-Malayali" Scheduled Tribe and the Community Certificate No.165938, dated: 15.04.2003 issued by the Revenue Divisional Officer, Dharmapuri vide R.Dis. No. 2015/2003/A5 is genuine one.

This regularization order is subject to the outcome of the W.P.'s pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to Group - IV Services 2015-2016, 2016-2017 and 2017-2018 recruitment.

The above individual is also informed that, he is placed under probation, for a total period of two years on the duty, within a continuous period of three years, as per Rule 32 (a) (i) of the Tamil Nadu Ministerial Service Rules. The officer concerned is requested to make necessary entries in the Service Register of the above mentioned individual and intimate the fact to this office immediately.


