- 6. The above individuals are hereby placed on probation for a total period of two years on duty within a continuous period of three years. On completion of two years of probation period, the head office shall declare for successful completion of probation, subject to the condition that they acquire the other required qualifications during the above period.
- The above individuals shall within the period of probation:-
 - (a) Complete the Foundational Training for a period of two months at Civil Services Training Institute, Bhavanisagar.

- 8. The above named individuals are informed further that:-
 - (a) Attention is invited to Act 20(5) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 according to which the physical fitness of the candidates has to be decided by the appointing authorities themselves. Therefore, you are requested to satisfy yourself about the physical fitness of the selected candidates before appointing them on regular basis. In respect of Differently Abled Candidates the nature of disability, percentage of disability and their capacity to perform the duty may be verified through the District Medical Board.
 - (b) Their appointment is liable for termination if they are found to be physically not fit.
 - (c) They will be governed by various rules and regulations and directions/instructions issued and amended from time to time as applicable to a State Government Servant of Tamil Nadu. Few Codes and Manuals, rules etc are noted hereunder:-

- 9. They are informed that in case if they fail to join duty before specified date, the same will be reported to the Secretary, Tamil Nadu Public Service Commission, Chennai -3 for removal of their name from the approved list of candidates for appointment.
- 10. They are informed that no kind of representation regarding joining time will be entertained and if he/she fails to join duty within the specified time and at the specified place, the Commission will be addressed for removal of his/her name from the approved list of candidates selected to the post of Junior Assistant with reference to Rule 23 of the Tamil Nadu Public Service Commission Rules of Procedure 2017.
- 11. They are informed that the appointment on provisional selection are made based on their claim made in their application for the said recruitment and that if any of their claim is found to be false, their selection and appointment will be cancelled without any further notice.

If so, he/she may be asked to surrender his/her employment exchange identity card, and the same may be sent by the Head of Office either to the District employment exchange where the candidate has registered his/her name or to the Director of Employment and Training, Chennai, so that the registration of the concerned candidate(s) may be removed from the Live Register of Employment Exchange. This shall be done under Intimation to the Directorate/TNPSC.

- 13. The candidates are hereby informed that they will have to serve in the office to which they are hereby posted for a minimum period of two years from the date of their appointment. They are also informed that they are liable for transfer once in three years to any of the stations in Tamil Nadu.
