**ORDER :**

Under Section 28 (1) of Tamil Nadu Government Servants (Conditions of Service Act, 2016), the temporary services of the following 2 persons, who have been selected and allotted by the Tamil Nadu Public Service Commission for appointment through Direct Recruitment to this Department vide their letter 1<sup>st</sup>, and 3<sup>rd</sup> read above and temporarily appointed as Store –Keeper, Grade-II in this Department vide Proceedings 2<sup>nd</sup>, 4<sup>th</sup> read above, are regularised subject to the conditions stipulated in Para No.3 of this proceedings, in the post of 'Store – Keeper Grade II' in Tamil Nadu Ministerial Service in the level of pay as per Tamil Nadu Revised Pay Rules 2017 of Rs.20,600-65,500 with effect from the dates mentioned against each:-

2. All the above 2 persons have produced physical fitness certificate while taking up the appointment. The above individuals are placed on probation for a period of 2 years on duty within a continuous period of 3 years from the dates of their regularisation subject to the following conditions as required in the Tamil Nadu Government Servants (Conditions of Service Act, 2016) to complete their probation.

- i) They should pass the Tamil Nadu Government Office Manual Test conducted by the Tamil Nadu Public Service Commission.
- ii) They should pass the Account Test for Subordinate Officers Part I conducted by the Tamil Nadu Public Service Commission.
- iii) They should successfully complete the two months Foundational Training at Civil Service Training Institute, Bhavanisagar.

3. The regularization is subject to the outcome of WP's (if any) pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High court of Madras relating to this recruitment.

4. They shall be allowed first increment on completion of duty period of one year. The second and subsequent increments will be sanctioned only on satisfactory completion of probation.

5. Orders fixing seniority will be issued separately.
