ORDER:

Thiru.R.Kumar while working as Junior Assistant, Principal District Munsif Court, Kuzhithurai, Kanniyakumari District died on 08.04.2019. His daughter Selvi.K.V.Ashmitha applied for the post of Junior Assistant in the Tamil Nadu Judicial Ministerial Service on compassionate grounds. The date of birth of Selvi.K.V.Ashmitha is 01.12.2000. She has passed S.S.L.C and H.S.C. She is thus eligible for appointment as Junior Assistant in the Tamil Nadu Judicial Ministerial Service. She was therefore appointed temporarily as Junior Assistant in the Additional District Munsif Court, Padmanabhapuram, Kanniyakumari District and joined duty on the Forenoon of 10.12.2020. The Registrar (District Judiciary), High Court of Madras, has sent proposal for regularisation of the services of the above individual as Junior Assistant in the Tamil Nadu Judicial Ministerial Service with effect from 10.12.2020 F.N.

2. The Government after careful examination have decided to accept the proposal of the Registrar (District Judiciary), High Court of Madras, Chennai and verified all the original certificates of the individual regarding the appointment in the post of Junior Assistant on compassionate grounds. Accordingly, the Government direct that the

services of Selvi. K.V.Ashmitha, D/o. Late Thiru.R.Kumar, formerly Junior Assistant, Principal District Munsif Court, Kuzhithurai, Kanniyakumari District appointed on compassionate grounds be regularised in the post of Junior Assistant under the Tamil Nadu Judicial Ministerial Service in the Additional District Munsif Court, Padmanabhapuram, Kanniyakumari District with effect from 10.12.2000 F.N., subject to the condition that the individual should possess the physical fitness to hold the post in which she is regularized and ordered accordingly. In view of the regularisation, the individual is eligible to draw the annual increments if any, as per the rules in force.

3. This order issues with the concurrence of the Labour Welfare and Skill Development Department vide its U.O.No.4593/Q1/2022-1, dated 14.03.2022 and Human Resources Management Department vide its U.O.No.2960/G2/2022, dated 03.03.2022.
