The above individuals are placed on probation for a period of 2 years on duty within a continuous period of 3 years from the dates of their regularisation subject to the following conditions as required in the Tamil Nadu Government Servants (Conditions of Service Act, 2016) to complete their probation ;

i) They should pass the Tamil Nadu Government Office Manual  
Test conducted by the Tamil Nadu Public Service Commission.

ii) They should pass the Account Test for Subordinate Officers Part I  
conducted by the Tamil Nadu Public Service Commission.

- iii) They should successfully complete the two months Foundational Training at Civil Service Training Institute, Bhavanisagar.

3. " The regularization is subject to the outcome of WP's (if any) pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Hon'ble High court of Madras relating to Group-II A 2017-2018 recruitment."

4. They shall be allowed first increment on completion of duty period of one year in their service. The second and subsequent increments will be sanctioned only on satisfactory completion of probation.
