On scrutinizing the application of Tmt.D.Vidhya, W/o.Late.K.P.Murugesan, (formerly Head Constable, Police Department, Namakkal, expired while in service on 01.06.2015), who has been appointed temporarily as Junior Assistant on compassionate grounds in the District Munsif Court, Rasipuram, Namakkal District and all other relevant records, it is found that her case does not require any relaxation of rules and exemption of Government Orders.
