ORDER:

Tmt.J.Sasikala was allotted through Direct Recruitment by the Tamil Nadu Public Service Commission and temporarily appointed as Assistant under section 17 (1) of the Tamil Nadu Government Servants (Conditions of Services) Act, 2016 in the reference 1st cited and she was posted as Assistant to the Office of the Director of Public Health and Preventive Medicine, Chennai-6 in the 2nd cited. She has joined duty in the post of Assistant on the Forenoon of 14.02.2017. She is fully qualified to hold the post.

The Tamil Nadu Public Service Commission in their letter in the reference 1st cited has also issued necessary concurrence for regularisation of the services of the candidates selected in Combined Civil Services Examination - II 2014-15 and 2015-16 (Non-Interview posts) (Group-II A services) post of Assistant in the Tamil Nadu Ministerial Services.

Accordingly, under section 28 (1) of the Tamil Nadu Government Servants (Conditions of Services) Act, 2016, the temporary services of Tmt.J.Sasikala, Assistant (Direct Recruitment) in the Office of the Director of Public Health and Preventive Medicine, Chennai-6 is regularised with effect from 14.02.2017 F.N.

She is placed on probation for a period of two years on duty within a continuous period of three years with effect from 14.02.2017 F.N. in the post of Assistant.

She should undergo the Civil Service Training within the probation period and she has to pass the following departmental tests in respect of this department as prescribed in Annexure IV, referred to in Rule 30 (b) in Page No.257 of Tamil Nadu Ministerial Service Rules.

- i) The Account test for subordinate Officers part-I
- ii) The Tamil Nadu Government Office Manual Test
- iii) The Tamil Nadu Medical code Test

Further, her regularisation is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to Group IIA 2014-2015 and 2015-16 recruitment.
