- 4. The above individual is placed on probation for a total period of two years on duty within a continuous period of three years with effect from the dates noted against each in para two above.
- 5. They are instructed that within the period of probation, they should pass the Tamil Nadu Government Office Manual Test, for declaration of their probation.
- 6. For declaration of probation in respect of Typist, the following qualification has also been prescribed in G.O.Ms.No.130 P & AR Department, dated 22.07.2008.

"To acquire the prescribed qualification in Computer Knowledge (Viz. Certificate Course in Computer on "Office Automation" awarded by Directorate of Technical Education) within the period of Probation (Viz. two years), and the probation will be declared only after getting a pass in the said Certificate Course. Otherwise they will be dealt with as per the provisions under General Rule 27 of Tamil Nadu State and Subordinate Services".

7. The above typists are entitled to draw second and subsequent increments only after declaration of their probation.
