## ORDER:-

In the Proceeding 1<sup>st</sup> read above, **Thiru.D.Dhamotharan**, **(TNPSC Reg.No.0501022375)** approved candidate selected through Direct recruitment for appointment to the post of Junior Assistant included in the Combined Civil Services Examination –IV (Group IV Services) in Tamil Nadu Ministerial Services who has been allotted to Treasuries and Accounts Department has been allocated to Chennai One Unit.

- 2. Thiru.D.Dhamotharan is regularly appointed as Junior Assistant in Tamil Nadu Ministerial Service in the time scale of 19500 62000 in the Level 08 of Pay Band 1 and posted to the O/o The Commissioner of Treasuries and Accounts, Chennai-35 in the existing vacancy.
- He is instructed to report before The Additional Director (Admin) of Treasuries and Accounts, Chennai-35 and join on duty immediately.
- It is informed that the seniority of the selected candidates for the posts of Junior Assistant has been fixed as per merit order.
- 5. It is informed that the individual not having "Adequate Knowledge in Tamil" should pass II class language test (full test) in Tamil within the period of probation as per Section 21(1) of Tamil Nadu Government Servants (Conditions of Service) Act 2016.
- 6. It is informed that the service regularization is subject to the outcome of the WPs pending on the files of the Hon'ble High Court, Madras / Madurai Bench of the Hon'ble High Court of Madras relating to

the recruitment to the post included in the Combined Civil Services Examination -IV (Group - IV Services).

- 7. It is informed that this appointment is purely temporary and if the original certificates submitted by him in support of educational qualification and community are found to be false at a later date, his appointment is liable to be cancelled without any prior notice.
- 8. The Additional Director (Admin) of Treasuries and Accounts, Chennai-35 is requested to verify the certificate of physical fitness and ensure whether the physical fitness of the candidate is satisfactory as contemplated under Act 20(5) of the Tamil Nadu Government Servants (Conditions of Services) Act 2016 before appointing the candidate on regular basis.
- 9. It is informed that no kind of representation regarding joining duty would be entertained and any failure to join duty within the specified time and at the specified place would result in his name being removed from the approved list of the candidate selected to the post of Junior Assistant (Non Security / Security) included in Combined Civil Service Examination IV (Group IV Services).
- 10. The Provisions in section 7(5) of the Tamil Nadu Government (Conditions of service) Act 2016 that if an approved candidate selected by the Commission for appointment, fails to join duty ordinarily within three month from the date of receipt of the orders directing her to join duty or within an early date if so specified by you in special circumstances, she shall forfeit her right for appointment to the post and her name should be recommended to the TNPSC for removal from the approved list of selected candidate immediately after lapse of such period.
- 11. The Additional Director (Admin) of Treasuries and Accounts, Chennai-35 is requested to ascertain from the individual whether she has registered her name with any Employment Exchange. If so, the individual may be asked to surrender her Employment Exchange identity card, and it may be sent to the respective Employment Exchange or to The Director of Employment and Training, Chennai, so that the registration of the concerned individual may be removed from the Live Register of the Employment Exchange.
- 12. The Additional Director (Admin) of Treasuries and Accounts, Chennai-35 is requested to verify the photo identity of the candidate which has been printed on the approved list of the selected candidates sent by the Tamil Nadu Public Service Commission which is enclosed herewith.

13. The Additional Director (Admin) of Treasuries and Accounts, Chennai-35 is requested to inform the date of joining of the individual immediately.
