ORDER:

The temporary services of Tmt. K. Mamtha, Typist Tamil Nadu Public Service Commission Candidate is regularised w.e.f 16.03.2013 F.N.

As per the direction of the Tamil Nadu Public Service Commission:

"The regularisation is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to Group IV 2013-2014 recruitment"

She has availed leave for 7 months (Maternity leave for 6 months and leave on loss of pay for 1 month) . Consequent to the completion of one year of service as on 16.10.2014, she is eligible for sanction of first periodical increment with effect from 16.10.2014, which is ordered to be advanced to 01.01.2015 (being the normal date of increment and monitory benefit w.e.f 01.08.2015 as detailed below:
