- 3. The regularization is subject to the outcome of the Writ Petitions pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to Group-IV services 2013-14 and 2014-15 recruitment.
- 4. The above individual is placed on probation for a total period of two years on duty within a continuous period of three years with effect from the dates noted against each in para two above.

- 5. He is instructed that within the period of probation, he should pass the Tamil Nadu Government Office Manual Test, for declaration of their probation.
- 6. For declaration of probation in respect of Typist, the following qualification has also been prescribed in G.O.Ms.No.130 P & AR Department, dated 22.07.2008.

"To acquire the prescribed qualification in Computer Knowledge (Viz. Certificate Course in Computer on "Office Automation" awarded by Directorate of Technical Education) within the period of Probation (Viz. two years), and the probation will be declared only after getting a pass in the said Certificate Course. Otherwise they will be dealt with as per the provisions under General Rule 27 of Tamil Nadu State and Subordinate Services".

7. The above typist is entitled to draw second and subsequent increments only after declaration of his probation.
