Thiru.E.Dinesh Kumar, who was selected by Tamil Nadu Public Service Commission as per the reference 2st and 3rd cited, and appointed temporary as Junior Assistant under rule 10 (a) (i) has joined duty in this college on **04.09.2020FN**. He is fully qualified to hold the post, he has completed one year of his service.

Hence, the temporary service of Thiru.E.Dinesh Kumar, **Junior Assistant is regularized** with effect from 04.09.2020FN i.e. the date of joining in the Government service subject to the following conditions.
