**ORDER:**

2) The services of the above individual in the post of Assistant is regularized with effect from the date of his joining (i.e. 15.05.2019 F.N). The regularisation is "subject to the outcome of WPs (if any) pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to Group-II A Services/2017-2018 recruitment" as per the TNPSC letter in the reference 1<sup>st</sup> cited.

- (iv) Two months Foundational Training Course

Conducted at Civil Service Training Institute, Bhavani Sagar.

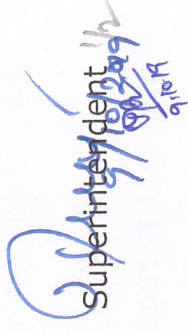
4) The seniority of the individual will be communicated on receipt of the same from the Tamil Nadu Public Service Commission.
