



ORDER:

Thiru.V.Udayakumar, while working as Junior Bailiff, Principal District Court, Villupuram died on 06.12.2016. His son Thiru.U.Veeramuthu, has applied for the post of Junior Assistant in the Tamil Nadu Judicial Ministerial Service on compassionate grounds. The date of birth of Thiru.U.Veeramuthu, is 11.08.1996. He has passed 10th (SSLC) and 12th (HSC). He is thus eligible for appointment as Junior Assistant in the Tamil Nadu Judicial Ministerial Service. He was therefore appointed temporarily as Junior Assistant in the Special Sub Court No.II to deal with Motor Claims Original Petitions Cases, Villupuram and joined duty on the Forenoon of 01.03.2017. The Registrar (District Judiciary), High Court of Madras, Chennai has sent proposal for regularisation of the services of the above individual as Junior Assistant in the Tamil Nadu Judicial Ministerial Service with effect from 01.03.2017 Fore Noon.

2. The Government after careful examination have decided to accept the proposal of the Registrar (District Judiciary) High Court of Madras, Chennai and verified all the original certificates of the individual regarding

the appointment in the post of Junior Assistant on Compassionate Ground. Accordingly, the Government direct that the services of Thiru.U.Veeramuthu, S/o. (Late) V.Udayakumar, formerly Junior Bailiff, Principal District Court, Villupuram appointed on compassionate grounds be regularised in the post of Junior Assistant under the Tamil Nadu Judicial Ministerial Service in the Special Sub Court No.II to deal with Motor Claims Original Petitions Cases, Villupuram with effect from 01.03.2017 Fore Noon. (subject to the condition that the individual should possesses the physical fitness to hold the post in which he is regularized and ordered accordingly. In view of the retrospective regularisation, the individual is eligible to draw the annual increments and arrears of pay and allowances if any, as per the rules)

3. This order issues with the concurrence of the Labour and Employment Department vide its U.O.No.12891/Q1/2020-2, dated 01.10.2020 and Personnel and Administrative Reforms Department vide its U.O. No.24872/G2/2020-1, dated 05.10.2020
