2. Thiru S Karthik, a candidate allotted by Tamil Nadu Public Service Commission, vide letter No.2393/PSD-I/2020, dated 29-05-2020, for appointment by direct recruitment to the post included in Combined Civil Services Examination, Group-IV Services as Junior Assistant in National Cadet Corps Department. Accordingly, Thiru S Karthik, has been appointed as Junior Assistant at NCC Directorate in the existing vacancy vide this Directorate letter cited reference (i) above.

3. Thiru S Karthik has reported for duty at this Directorate on the forenoon of 03 Aug 2020 along with Certificate of physical fitness (enclosed) as prescribed in FR 10.

4. **The appointment of the above individual is on regular basis since his application has been admitted finally by the commission** "The above individual is hereby informed that his regularization of service is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to Combined Civil Service Examination-IV for the year 2018-19 and 2019-20 recruitment."

**PLACING ON PROBATION:**

5. Thiru S Karthik has been absorbed as Junior Assistant in existing vacancy of this Directorate. The individual is placed on probation for a total period of two years on duty within a continuous period of three years, with effect from **03 Aug 2020(FN)**. Orders on declaration on probation of the individual will be issued by this Directorate on completion of probation period by the individual and subject to the condition that he acquires the other required qualifications during the above period.

6. The above individual shall within the period of probation:-

(a) Complete the Foundational Training for a period of two months at Civil Services Training Institute, Bhavanisagar.

(b) Pass the following tests, namely:-

(i) Account Test for Subordinate Officers, Part -I

(ii) Departmental Test conducted by the Deputy Director General NCC.

7. The pay of the individual is fixed in Level-8 (19500 - 62000) of The Tamilnadu Revised Pay Rules, 2017 as follows:-

8. The individual is admitted to Tamil Nadu Government Servant Family Security Fund Scheme and Special Provident Fund 2000. Necessary nomination form has been obtained from him and recorded.

9. He will be governed by Tamil Nadu Government Contributory Pension Scheme 2003 as per G.O.Ms.No.430, Finance (Pension) Department, dated 06.08.2004. On receipt of Index Number from Accountant General, Tamil Nadu, Chennai, appropriate subscription will be recovered from his pay and allowances.

10. A sum of Rs.70/- p.m. will be recovered from the individual towards Tamil Nadu Government Employees Special Provident fund Scheme 2000 as per G.O.Ms.No.504 Finance (Pension) Department dated 02 Nov 2000. The number of installments for the above subscription is **373 (Date of birth 31-08-1991; Date of Joining - 03-08-2020 & Date of Retirement 31-08-2050)**. The recovery will be made from the pay and allowances through pay bill commencing from **Aug 2020**. Necessary nomination form has been obtained and recorded.

11. The individual has also been admitted to New Health Insurance Scheme, 2016. A sum of Rs.180/-p.m will be recovered from the individual towards New Health Insurance Scheme, 2016 vide G.O.Ms.No.202 finance (salaries) Department dated 30 Jun 2016.
