

ORDER:

In the letter 3rd read above, the Deputy Director General, National Cadet Corps, Chennai has stated that Thiru. K. Thangaraju who was serving as Office Assistant at 2 (TN) Bty NCC, Coimbatore died while in service on 29.06.2015.

2. In the proceedings 2nd read above, Thiru. T. Vignesh S/o (Late) K. Thangaraju was appointed as Junior Assistant under compassionate ground in the existing vacancy at NCC Group HQs, Madras 'A', temporarily with effect from 24.09.2018 FN pending regularization of services by the Government since appointment to the post of Junior Assistant is under the exclusive purview of Tamil Nadu Public Service Commission.

3. The Deputy Director General, National Cadet Corps has further stated that the individual Thiru T. Vignesh is fully qualified to hold the post of Junior Assistant. Hence, the DDG, NCC has requested the Government to regularize the services of Thiru. T. Vignesh who was appointed as Junior Assistant under compassionate ground w.e.f 24.09.2018 F.N.

In the G.O 1st read above, orders have been issued to dispense with the procedure of obtaining the concurrence of the Tamil nadu Public Service Commission for regularizing the services of the individuals appointed under compassionate grounds.

5. The Government after careful examination of the proposal of the DDG, NCC on para 3 above, regularize the services of Thiru T. Vignesh S/o. Late Thiru. K. Thangaraju, who was appointed as Junior Assistant under compassionate ground with effect from the date of his temporary appointment i.e., from the forenoon of 24.09.2018 subject to the condition that he should possess the necessary physical fitness for the post. The individual is also eligible to get annual increments and arrears, if any, as per rules in force, consequent to the regularization of services.

6. This order issues with the concurrence of L&E and P & AR Departments vide their U.O No. 4777/ Q2/ 2020-1, dated 29.05.2020 and 13211/G2/ 2020-1, dated 02.06.2020 respectively.
