

"The regularization is subject to the outcome of the writ petitions pending on the files of the Honorable High court of Madras / Madurai Bench of the Honorable High court of Madras relating to the recruitment to the post included in Combined Civil Services Examination - IV (Group IV).

She is placed on probation for a period of two years within the continuous period of three years with effect from the date of regularization of temporary service.

She is also instructed to pass the departmental test in Tamil Nadu Medical code within the period of two years and also informed that she should complete foundational training in Bhavanisagar within the period of probation.
