Further, the individual is hereby informed that “the regularization is subject to the outcome of the WPS relating to Group-IV 2007-2008 to 2012 – 2013 recruitment pending on the files of the Hon’ble High Court of Madras/Madurai Bench of the Hon’ble High Court of Madras” as stated in the letter of the Tamil Nadu Public Service Commission in 1<sup>st</sup> and 3<sup>rd</sup> reference cited, and the above candidates are ordered to be commenced their period of probation of two years within a continuous period of three years from the date of regular appointment.

The pay and date of increment of the above individual shall be regulated as per orders passed in G.O.Ms.No.558 P & A.R. Department, dated 24.06.1983 with effect from the date of regularization now ordered and increment if already granted be revised.

Further, The above said candidates are directed to qualify themselves in the Certificate Course in Computer on Office Automation awarded by the Technical Education Department as additional Technical Educational qualification for the Typist/Copyist and Copyist/Typist prior to completion of Probation, otherwise they will be dealt with as per the provision under General Rule 27 of Tamil Nadu State and Subordinate Services.
