Sub: TNPSC Recruitment (Direct) - Posts of Village Administrative Officer / Junior Assistant / Bill Collector, Grade-I / Bill Collector / Field Assistant / Store Keeper included in Combined Civil Services Examination - IV (Group-IV - Date of Examination 24.07.2022) - Forwarding the list of selected candidates for issuance of appointment orders - Regarding.

Ref: Notification No.07/2022, dated 30.03.2022.

I am directed to say that the Commission has conducted the written examination on 24.07.2022 FN for direct recruitment to the posts of Village Administrative Officer / Junior Assistant / Bill Collector, Grade-I / Bill Collector / Field Assistant / Store Keeper included in Combined Civil Services Examination - IV (Group-IV) Service in TNSS / TNMS/ TNJMS / TNSLRSS.

2. I am to add that a list containing the name and other particulars of candidates who have been selected provisionally for appointment by direct recruitment to the post of Junior Assistant included in Combined Civil Services Examination - IV (Group-IV) with his photographs enclosed herewith for issuing appointment orders. The rule of reservation of appointment as envisaged in Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act 2016 applies to this recruitment.

3. I am to add that the application(s) of the **78** selected candidate(s) mentioned in the list are admitted finally and his temporary services may be regularised from the date of his joining duty in your Department. **Further the seniority of the above selected candidate for the said post has been fixed as per merit order.**

4. While regularizing the services of the selected candidates, the following para may be included in the regularization orders to be served to the individual(s):-

"The regularization is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras/Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in Combined Civil Services Examination - IV (Group-IV).

5. The photograph of the selected candidate printed in the list is sent with for verification of the identity of the candidate at the time of appointment.

6. I am to invite attention to Section 20(5) of the Tamil Nadu Government Servant (Conditions of Service) Act 2016 according to which the physical fitness of the candidate(s) has to be decided by the appointing authorities themselves. I am, therefore, to request you to satisfy yourself about the physical fitness of the selected candidate(s) before appointing him / her on regular basis. In respect of Differently Abled candidates the nature of disability, percentage of disability and his capacity to perform the duty may be verified through the District Medical Board

7. The candidate(s) selected for appointment should be issued with an appointment order early and there should not be any delay in appointing the candidates.

8. The selected candidate(s) whose application(s) were admitted finally / provisionally have been informed of their Department allotted by the Commission's office during Physical Certificate Verification-cum-Counselling and the finally / conditionally admitted candidate(s) have been issued with allotment orders.

9. I am to add that a paragraph may be included in the appointment orders to be issued to the candidate(s) to the effect that no kind of representation regarding joining time will be entertained and that if he / she fails to join duty within the specified time and at the specified place, his/her name will be deleted from the approved list of candidates selected to the post of **Junior Assistant included in Combined Civil Services Examination - IV (Group-IV)**. As per para 8A of Tamil Nadu Public Service Commission - Rules of Procedure the name of such candidate(s) may be deleted by the Appointing Authority themselves and the fact of the deletion may be intimated to the TNPSC and the consequent vacancies may be added to the future estimate. The appointment orders should be sent to the individual(s) only by RPAD.

10. I am to invite attention to Section 7 (5) of the Tamil Nadu Government Servants (Conditions of Service) Act 2016 and to say that if an approved candidate selected by the Commission for appointment, fails to join duty ordinarily within three months from the date of receipt of the orders directing them to join duty or within an earlier date if so specified by you in special circumstances, he / she shall forfeit his / her right for appointment to the post and his / her name should be removed from the approved list of selected candidates. However, in very special circumstances, the appointing authority may extend the time limit referred to in this Sub-section upto six months for valid reasons.

11. Another paragraph to the effect that, "the appointment is temporary and selection is made based on their claims made in their application for the said recruitment and that if any of their claim is found to be false, their selection and appointment will be cancelled without any further notice," may also be included in the appointment order.

12. I am to request that a copy of Proceedings in which the candidate is appointed may be communicated and the particulars of date of joining of the candidates and those who have not joined duty after obtaining the appointment orders may also be communicated to the Commission immediately without fail.

13. I am to state that the candidate **Thiru V.Azhakesan (Sl.No.87)** mentioned in the list has been selected provisionally and conditionally subject to verification of his Community claim by the District Revenue Officer / District Vigilance Committee / State Level Scrutiny Committee.

- i. The candidate has claimed to belong to Hindu-Malayali... ST and has obtained the Community Certificate from RDO, Namakkal.

The Commission has decided that the State Level Scrutiny Committee may be addressed by the Head of the Department concerned / Unit Officer concerned, to verify the community claim of the candidate(s) and his claim may be accepted on receipt of the final report from the State Level Scrutiny Committee, along with records of enquiry. Further, I am also to state that, if his / her Community claim is found to be **not genuine**, he is liable to be terminated from service and for which penal and legal action including recovery of salary as consequence thereof will be initiated. The temporary services of the said candidate(s) should not be regularised in the said post until his Community claim is accepted as genuine. This fact may be incorporated in the appointment orders to be issued to the candidate(s). After acceptance of his Community claim, the services of the candidate may be regularized by Unit Officer themselves and the fact may be intimated to the Commission for its information.

14. I am further to state that the selection of the following candidates is purely provisional and conditional subject to verification and acceptance of the PSTM (Persons Studied in Tamil Medium) certificate from the competent authority.

15. I am therefore, to request that **the PSTM claim of the above said candidate(s) may be referred to the appropriate authorities viz. The Director of School Education for verification duly obtaining the PSTM certificates from the above said candidates after joining duty.** The PSTM claim may be accepted after the receipt of genuineness report from the authorities concerned. After acceptance of his / her PSTM claim, the fact may be informed to the Commission along with a copy of the genuineness report, so as to finalise his / her provisional and conditional selection. The temporary services of the above said candidate(s) should not be regularised in the said post until his/her/their claim is found to be genuine.

16. I am to request that as soon as the selected candidate(s) join(s) duty, it may be ascertained from them whether they have registered their name(s) with any employment exchange. If so, he/she may be asked to surrender their employment exchange identity card, and the same may be sent by you either to the District Employment Exchange where the candidate(s) have registered their name(s) or to the Director of Employment and Training, Chennai, so that the registration of the concerned candidate(s) may be removed from the Live Register of Employment Exchange.

17. I am also to request that the receipt of this letter together with its enclosures may kindly be acknowledged at an early date.
