ORDER:

Tmt. N. Savithiri (Reg.No.27506105) was selected provisionally for appointment to the post of Assistant in Transport Department through TNPSC and her selection list was forwarded to this Department vide reference 1st cited, for giving conditional appointment to her, since she belongs to Scheduled Tribe community. Accordingly she was posted as Assistant at Regional Transport Office, Krishnagiri vide the reference 2nd cited. The individual also joined in the Regional Transport Office, Krishnagiri on the forenoon of 01.07.2016.

While forwarding her selection list, TNPSC have stated that,

"the Commission has decided that the State Level Scrutiny Committee may be addressed by the Head of the Department concerned itself and the community claim of the individual may be examined on receipt of the final report from State Level Scrutiny Committee, along with records of enquiry and may be accepted, if found genuine. The Commission also reiterates that her temporary service should not be regularised in the said post, until her community claim is accepted by the Department. The Commission also requires to inform the details of acceptance of her community claim, latter."

Now in the reference 5th cited, the State Level Scrutiny Committee has issued a proceedings in favour of Tmt. N. Savithri, D/o. Thiru.Nachiyappan for her community claim as "Hindu-Malayali" Scheduled Tribe and the

Community Certificate No.016360, dated: 07.06.1997 issued by the Revenue Divisional Officer, Tirupattur vide R.Dis. No. 4900/1997 is genuine one.

Therefore, based on the above final proceedings issued by State Level Scrutiny Committee, the community claim is hereby accepted and the services of Tmt.N.Savithri, Assistant, Regional Transport Office, Chennai(west) is **regularized in the cadre of Assistant from the date of her joining in this department, i.e., 01.07.2016 F.N**
