"It is also informed that the list enclosed, does not indicate the order of seniority. The seniority list will be informed as and when received from the Tamil Nadu Public Service Commission".

The Assistants whose temporary services are regularised in this order are placed on probation for a period of two years within the continuous period of three years from the date of regularization.

They should pass the following Departmental Test / Qualification within their Probationary period.

1. Tamilnadu Medical Code
2. Accounts Test for Subordinate Officers Part – I
3. Tamilnadu Government Office Manual Test
4. Foundational training for a period of two months at Civil services Training institute, Bhavanisagar
5. Should Possess adequate knowledge in Tamil, If not should pass the Language test in Tamil.
