ORDER IN A.No. 33 /2016, Dated 16.03.2016.

The following persons were appointed as Typist and Junior Assistant by way of compassionate Ground as per 1st and 2nd read above.

13/16 The temporary services of the said individuals have not been regularized so far in this Unit. No punishment have been awarded, no disciplinary proceedings have been pending against the staff concerned and the individuals have been acting as regular staff since their date of appointment. They have acquired requisite qualifications required for the posts concerned and no relaxation of rules and exemption of rules is necessary.


