The Principal District Judge, Tirunelveli, has forwarded the proposal for regularisation of service, in respect of Thiru.M.Esakkimuthu, S/o. Thiru.P.Masanam, (formerly Office Assistant (Retired on Medical Invalidation), Principal District Munsif Court, Valliyoor, Tirunelveli district), who has been appointed temporarily as Junior Assistant on compassionate grounds in the Additional Sub Court, Tirunelveli and had joined duty on 01.04.2019 F.N.

The Government in G.O. 1<sup>st</sup> cited have issued orders and guidelines to be followed for facilitating speedy regularisation of service of employees who were appointed on Compassionate ground during the period from 02.02.2016 to 31.12.2019 and said G.O. has been communicated to all the Appointing Authorities/Principal District Judges/District Judges/Unit Heads.
