2) In the Chief Office circular memorandum in C.No.041769/AR.1/2016, dated.21.12.2017, instructions were issued for the regularization of services of those who were appointed as Junior Assistant from the post of Data Entry Operators, as follows:

*For regularizing the service of those who were appointed from one sub-ordinate service to another sub-ordinate service, the concurrence of the TNPSC is not necessary.
