ORDER:

Under Rule 23 (a) of the General Rules for the Tamil Nadu State and Subordinate Services the temporary services of *Selvi* Tmt.T.Sumathikumari, Steno - Typist Grade III, O/o the Chief Water Analyst, King Institute, Guindy, Chennai-32 is regularised with effect from 24.12.2012 F.N.

She is placed on probation for a period of two years on duty within a continuous period of three years with effect from 24.12.2012 F.N. in the post of Steno - Typist Grade III.

As per G.O.Ms.No.130 Personnel and Administrative Reforms (S) Department dt:22/07/2008 & G.O.(Ms) No.43 P&AR(S) dt:17/04/2009 she should possess a **certificate course in computer on Office Automation** conducted by the Technical Education Department or she should acquire such qualification within the period of probation.
