

ORDER:

In the Proceedings 1st read above, the Deputy Director General, National Cadet Corps directed ~~to~~ the Officer Commanding, 9 (TN) Sig Coy NCC to appoint Tmt. S. Petchiammal (W/o late Thiru S. Gomathi Sankar expired while serving as Driver at 3 (TN) Air Sqn (T) NCC, Trichy on 22.01.2022) as Junior Assistant under compassionate ground. Accordingly, the Officer Commanding, 9 (TN) Sig Coy NCC appointed Tmt. S. Petchiammal as Junior Assistant in the existing vacancy at 9 (TN) Sig Coy NCC, Tirunelveli temporarily with effect from 29.08.2022 F.N vide proceedings 2nd read above.

2. In the letter 3rd cited, the Deputy Director General, National Cadet Corps, Chennai has requested the Government to regularize the services of the individual Tmt. S. Petchiammal (W/o late Thiru S. Gomathi Sankar) who was appointed as Junior Assistant under compassionate ground from the date of her appointment i.e., from 29.08.2022 F.N. The Deputy Director General, National Cadet Corps has also certified that the individual fulfills all the criteria and is qualified to hold the post of Junior Assistant on the date of the temporary appointment.

3. The Government, after careful examination of the proposal of the Deputy Director General, National Cadet Corps, Chennai in para-3 above, hereby order to regularize the services of Tmt.S.Petchiammal

(W/o late Thiru S. Gomathi Sankar) appointed as Junior Assistant under compassionate ground with effect from 29.08.2022 F.N, subject to the condition that she should possess the necessary physical fitness for the post of Junior Assistant. The individual is also eligible to get the monetary benefit of annual increments and arrears, if any, as per the rules in force, consequent to the above regularization.
