ORDER:

Thiru.M.Tamilselvan who was provisionally selected as Junior Assistant by Tamil Nadu Public Service Commission, re-allotted to Director of Medical Education side by the Director of Medical and Rural Health Services, Chennai-6 vide reference 1st cited, and posted to Tamil Nadu Government Multi Super Speciality Hospital, Chennai-2 vide reference 2nd cited, was temporarily appointed as Junior Assistant under Rule 17 (i) of Tamil Nadu Government Servants (conditions of service) Act 2016 in the Pay matrix Level 8 (Rs.19500 – 62000) with usual allowances admissible to the post. He has joined duty on the Forenoon 23.04.2019 at Tamil Nadu Government Multi Super Speciality Hospital, Chennai-2 vide this Office Proceedings 4th cited.

Consequent on the receipt of certificate genuineness of his ST community certificate from the Tamil Nadu State level scrutiny committee –I Adi Dravidar and Tribal welfare Department vide reference 5th cited, the temporary services of the individual are regularized with effect from the date of joining duty that is 23.04.2019 FN.

"The regularization is subject to the outcome of the Writ Petitions Pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in combined civil Services Examination IV for the year 2015-2016,2016-2017 and 2017-2018.
