ORDER:

Selvi.D. Subasri, had been selected in Group - IV services competitive examination for 2013-2014 conducted by the Tamilnadu Public Service Commission and allotted to the Department of Medical and Rural Health Services as per the reference 1<sup>st</sup> cited. As per reference 2<sup>nd</sup> cited, she was temporarily appointed as Typist under Rule 10a(1) of the Tamilnadu State and Subordinate Services in the pay band of Rs.5200 - 20200 + GP Rs.2400 and posted to the office of the Joint Director of Health Services, Cuddalore. She had joined duty as Typist on the F.N. of 01.10.2014. She is fully qualified to hold the post of Typist.
