ORDER :

The candidates mentioned in the annexure to this proceedings are selected provisionally for appointment by Direct Recruitment to the post of **Junior Assistant (Non Security)** in the Tamil Nadu Ministerial Service(Date of Examination 24.07.2022) by the Tamil Nadu Public Service Commission and provisionally appointed as **Junior Assistant (Non Security)** in the Tamil Nadu Ministerial Service with effect from the date of joining duty, in the level of pay of Rs.19500-71900 (Level 8) with allowances admissible as per rules in force, and allotted to Agricultural Engineering Department as per the reference 3rd cited.

2) In continuation to the reference (3rd) cited, the candidates allotted to this Department are re-allotted to the District Executive Engineers (AE)/ appointed in this office as mentioned in column number (5) of the Annexure to this order. The Executive Engineers (AE) concerned are requested to issue posting orders to the candidates allotted as per the Annexure to this order by registered post with acknowledgement due with a copy marked to this office. The joining time may be allowed for 15 days from the date of receipt of the posting order.

2.(i) The candidates for whom postings given in this office (TNPSC serial no.38, 41, 46, 47,53 ,79 and 83 of annexure to this order) shall join duty directly in this office, without expecting further posting order.

3) Since, the selected candidates listed in the annexure are finally admitted by Tamil Nadu Public Service Commission, their temporary services may be regularized from the date of their joining duty in the post of Junior Assistant (Non Security).

4) The following paragraph shall be included in the regularization order of candidate.

"The regularization is subject to the outcome of the WPs pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Hon'ble High Court of Madras relating to the recruitment to the post included in Combined Civil Services Examination-IV (Group-IV)"

5) The Authorities concerned are requested to verify the original certificates and photographs of the selected candidates at the time of joining duty.

6) As per the Tamil Nadu Government Servant (Conditions of Service) Act 2016 section 20 (5), the appointing authorities are requested to ensure the candidates to produce the physical fitness at the time of joining duty. In respect of differently abled candidates the nature of disability, percentage of disability and their capacity to perform the duty shall be verified by the posting authority through District Medical Board.

7) The Executive Engineers (AE) concerned shall issue the posting orders to the candidates immediately without any delay.

8) The candidates shall not be entertained for any kind of representation regarding joining duty and if the candidates fail to join duty for the post of junior Assistant (Non Security) within the time specified by the posting authority, the name of such candidates may be sent immediately to this office for removing such names from the approved candidates selection list as per Para 8A of Tamil Nadu Public Service Commission-Rules of Procedure. The posting orders should be sent to the candidates only by Registered Post and Acknowledgement Due (RP/AD).

9) Since the appointment on provisional selection are made based on their claim made in their application for the said recruitment and that if any of their claim is found to be false, their selection and appointment shall be cancelled without any further notice.

10) The joining and non joining report of the candidates may be sent to this office in order to forward the same to the Commissioner of Agriculture office.

11) As per reference (1) cited, It is informed that the Selection of the following candidates is purely provisional and conditional subject to verification and acceptance of the PSTM (Persons Studied in Tamil Medium) Certificate from the competent authority.

12) It is informed that the PSTM Claim of the above said candidate(s) may be referred to the appropriate authorities viz. The Director of School Education for verification duly obtaining the PSTM certificate from the above said candidates after joining duty. The PSTM claim may be accepted after the receipt of genuineness report from the authorities concerned. After acceptance of his/her PSTM claim, the fact may be informed to the Commission along with a copy of the genuineness report, so as to finalise his/her conditional selection. The temporary services of the above said candidate(s) should not be regularized in the said post until his / her / their claim is found to be genuine.

13) The selected candidates mentioned in the Annexure and who join duty are directed to report whether they have registered their names with any Employment Exchange. If so, they should surrender their Employment Exchange identity card, to their Head of Office / Controlling Offices concerned while joining duty, which will be sent to the concerned District Employment Office so that registration of the concerned candidates may be removed from the Live Register of Employment Exchange.

14) As per sub rule 3 of rule 7 in Tamil Nadu Government Employees conduct rules 1973, the candidate should furnish property statement within 3 months from the date of joining.
