**ORDER:**

Under Section 28(1) of the General Rules for the Tamil Nadu Government Servants (Conditions of Service) Act 2016 the temporary services of Tmt.N.Akilandeswari, Typist, Office of the Chief Water Analyst, Regional Public Health Water Analysis Laboratory, Trichy in the post of Typist is regularised with effect from 22.11.2017 F.N.

2. She is placed on probation for a period of two years on duty within a continuous period of three years with effect from 22.11.2017 F.N in the post of Typist.
